## TERMS OF TRADE TERM FOR JAPANESE DEALER STOCK

1. **GENERAL**—Together with WTL JAPAN's Terms of Trade, these additional terms govern JAPANESE DEALER STOCK transactions.
2. **PROCUREMENT**—JAPANESE DEALER STOCK is offered by nonparty auctions, wholesalers, retailers, and private individuals. WTL JAPAN is not the seller. For JAPANESE DEALER STOCK, WTL JAPAN offers to buy and processes payment as buyer's buying agent.
3. **WARRANTIES DISCLAIMED**—JAPANESE DEALER STOCK is offered as is with no implied warranties, including fitness for buyer's purpose and merchantability.
4. **SUPPLIER-CONTROLLED INVENTORY**—Please be aware that the inventory of JAPANESE DEALER STOCK is managed by suppliers, and there is a possibility that units may be sold or taken off the market between the time you make a payment to WTL JAPAN and when WTL JAPAN procures the item from the supplier. In the event that a unit is sold out or unavailable, WTL JAPAN will act upon your instructions either by using your payment for a different unit or by refunding your payment.
5. **PRICING AND SALE** — Regarding pricing and sale, our cars are priced in EUR, GBP, JPY, or USD currencies. Please note that ownership title of the purchased car will remain with WTL JAPAN until full payment is received. WTL JAPAN retains a security interest in the cars to secure any outstanding amounts owed to carriers, customs, and port authorities. By proceeding with the purchase, you grant authorization for any necessary filings and actions to be taken in order to perfect the security interest held by WTL JAPAN.
6. **PAYMENT**— You are required to make the payment on or before the due date specified in the invoice. The payment will be considered received by WTL JAPAN upon the successful processing of your electronic funds transfer. Please note that any bank charges or additional transaction costs that may apply are not included in the invoice price and are your responsibility to settle.
7. **DELIVERY AND SHIPPING** — Once full or partial payment is made, WTL JAPAN will arrange shipping in accordance with the carrier's terms and conditions. The designated delivery point will be the carrier's facility. It is important to note that the risk of any loss or damage to the purchased item transfers to you upon the carrier accepting the goods. The shipping schedules are solely controlled by the carriers, and any delays, errors, or failure to perform on their part are beyond WTL JAPAN's liability. As the buyer, it is your responsibility to adhere to the relevant import regulations, which may include restrictions on car age, class, and driving side. In the event of non-compliance or entry denial, WTL JAPAN will not be held accountable, and you agree to indemnify WTL JAPAN against any liability as the shipper for such an order falling outside the regulatory framework.  
Upon the arrival of the Proof of Delivery (POD), WTL JAPAN recommends checking and replenishing engine oil, radiator coolant, and any other consumables as needed. This ensures the proper functioning and maintenance of the vehicle.
8. **VEHICLE DOCUMENTS** — The original documents will be released and dispatched to you once full payment has been received. It is essential to ensure timely and complete payment to initiate the processing and dispatching of the documents before the Proof of Delivery (POD) arrival. Please note that WTL JAPAN will not be held responsible for any losses resulting from damaged, delayed, inaccurate, lost, uncorrected, unissued, or withheld documents. As the recipient, it is your responsibility to make timely payments and verify the accuracy of the documents upon receipt.
9. **NONPAYMENT AND CANCELLATION**— In the event of your failure to make full payment of the invoice price by the specified due date, the car will be considered unpaid. Consequently, WTL JAPAN reserves the right to take possession of the unpaid car and may opt to resell it. Furthermore, WTL JAPAN has the authority to allocate received payments to unpaid cars at its discretion, regardless of any specific payment allocation made by you. Once shipping arrangements have been confirmed by WTL JAPAN, the order becomes non-cancelable. In the event that you are unable to complete full payment after the shipping arrangements have been finalized, any partial payments made up to that point will be forfeited.
10. **NONPARTY PROVIDERS**—Nonparty service providers (e.g., banks, carriers, and couriers) are independent entities not under WTL JAPAN control. WTL JAPAN is not liable for any losses arising from their services, car custody, or delays. Nonparty-provided manufacture and registration details may occasionally be incorrect, so reliance on them is at your own risk.
11. **LIMITED LIABILITY**— WTL JAPAN's liability shall be restricted to the invoice price of the respective car(s) in question. In no event shall WTL JAPAN be responsible for any consequential, indirect, or punitive damages, nor for any loss of business, profit, or use.

12. ANTI-SOCIAL FORCES— WTL JAPAN maintains a strict stance against engaging with organized crime and is committed to preventing any association with anti-social elements. To uphold this commitment, we carefully screen potential business partners to ensure they have no affiliations with anti-social entities. Additionally, our procurement and sales contracts explicitly exclude any involvement with anti-social forces. Any transaction found to contravene these policies will be strictly prohibited.

13. DATA HANDLING— At WTL JAPAN, we adhere to the regulations set forth in the Japan Act on the Protection of Personal Information, Act on the Use of Social Security and Tax Number System, and other relevant data-handling laws. All subject data is treated in accordance with WTL JAPAN's Privacy Policy, which outlines our commitment to safeguarding personal information and ensuring its lawful and secure handling.

14. KENYA VEHICLE IMPORTS — Kindly be aware that imported cars destined for Kenya are subject to duties, which are determined based on their engine size and year/month of manufacture. Furthermore, these vehicles must undergo destination inspection conducted by the KBS, and the associated costs and risks are solely borne by you as the importer. Please note that WTL JAPAN warrants that the cars will align with their provided descriptions but does not guarantee their passing of inspection. It is your responsibility to select vehicles that comply with the necessary requirements. We recommend verifying the relevant information at KRA, before finalizing your purchase.

WTL JAPAN shall not assume liability for cars that fail to pass the inspections or any related consequences arising from non-compliance.
